### BRIEF EMPLOYMENT HISTORY

Peter has an extensive history of employment with local government authorities including:

- 1. A period of approximately 18 months employed as an Assistant Town Planner with Hornsby Council in the late 1970's.
- 2. A period of approximately 12 months with Warringah Council during 1980 and 1981 as an Assistant Town Planner, predominantly involved in statutory planning functions.
- 3. A period of 8 years employed by North Sydney Council in the role of Town Planner and involved in policy formulation and review, statutory planning, development application assessment and provision of expert testimony in the Land and Environment Court of New South Wales.

In 1988 Peter was appointed a Director of ES Turnbull Pty Limited, Town Planners, which was later re-incorporated as The Turnbull Group Pty Limited. Peter continued as a Director until December 2006.

In 2007 Peter established a new practice with the name Turnbull Planning International Pty Limited and is a Director of that Firm. The firm has a broad focus and is involved in work in Phoenix Arizona and Austin Texas.
